Labor Law Posters Available Through the Yuba-Sutter Chamber of Commerce

The Yuba-Sutter Chamber partners with the California Chamber of Commerce to offer posters and other labor law materials that are required by law. The 2010 Labor Law posters are now available for sale through the Chamber at a reduced cost of \$23 plus tax for a non-laminated poster. The poster includes all 16 required state & federal notices. It is also available in Spanish. All businesses with employees must have a Labor Law poster or face fines up to \$7000. Added materials this year include a guide to protecting credit card data and an exporting guide for California businesses.
